# **Guidelines for SmartME Application Submission**

SIFA FC Funding Window 3 (FW3) uses the SmartME online platform for the preparation and submission of proposals. This tool is available to applicants on the SIFA website (www.skillsafrica.org).

SmartME is an online system designed to manage the SIFA Innovation Fund Calls for Proposals and project implementation cycle. The proposal must be drafted in the format prescribed on this platform. SmartME works to improve the project partnership's efficiency by automating aspects of the application process. It provides the team with access to all the relevant information pertaining to the proposal. Submitting an application via email, regular mail, or any other channel is not possible, and submissions made in any way other than through SmartME will automatically be rejected.

Applicants can log onto the SmartME system and apply online as soon as the SmartME system has opened. For Funding Window III, the SmartME system opens on January 13, 2023. An applicant can draft, complete, and submit information without the need to store any documentation or lose any unsaved work. All additional documentation can be uploaded onto the system and remains available to the applicant.

NOTE: SmartME system is used by SIFA FMT and AUDA-NEPAD to monitor the progress of the grantee projects, including communication with the Project Coordinator.

Interested applicants can register on the SmartME system as follows:

## Step 1

Log into the SIFA website and click apply on the homepage.


Click on the blue icon saying, "Apply in SmartME."

Click to Watch


The blue icon in Step 2 will take you to the Login space below. Click on the "Do not have an account yet click here to register," sentence.






# Step 4

# Step 5


Once you register, you will receive an email (to the email address that you entered in Step 4) that will require your confirmation. Click on this email.






## Step 6
